A. MEETING DAY, DATE & TIME

B. REGISTRATION ON THE DAY OF THE 55TH AGM

1. Registration will commence at 9.30 a.m. and will end at the time determined by the Chairman of the Meeting. Please read the signage to ascertain the registration area and proceed for registration.
2. Please present your ORIGINAL National Registration Identity Card (NRIC) or Passport (for foreign member) to the registration staff for verification. Please ensure your NRIC or Passport is returned to you after registration.
3. Registration must be done in person. Please also take note that you will not be allowed to register on behalf of another person even with the original NRIC or Passport of that other person.
4. The registration counters will only handle verification of identity, registration and revocation of proxy/proxies. If you have other queries, please proceed to the Help Desk.
5. Upon verification and registration:
 - (a) Please sign on the attendance list and an identification wristband will be provided at the registration counter;
 - (b) If you are attending the 55th AGM as a member as well as a proxy, you will be registered once and will only be given one identification wristband; and
 - (c) No person will be allowed to enter the meeting hall without wearing the wristband. There will be no replacement in the event that the identification wristband is lost or misplaced.

C. ENTITLEMENT TO PARTICIPATE AND VOTE AT THE 55TH AGM

1. Only shareholders whose names appear on the **Record of Depositors** as at **19 June 2026** shall be eligible to attend and vote at the 55th AGM or to appoint proxy(ies), corporate representative(s) or attorney(s) to attend and vote on their behalf at the 55th AGM.

Shareholders who are unable to attend the 55th AGM but wish to exercise their votes are encouraged to appoint proxy(ies) or Chairman of the Meeting to attend and/or vote on their behalf at the 55th AGM by indicating the voting instructions on the Proxy Form in accordance with the notes and instructions printed therein.

Shareholders who wish to personally attend the 55th AGM **MUST NOT** submit any Proxy Form for the 55th AGM. A shareholder will not be allowed to attend the 55th AGM together with the appointed proxy(ies).

D. APPOINTMENT OF PROXY/CORPORATE REPRESENTATIVE/ATTORNEY

1. Duly executed Proxy Form(s) and/or other document(s) relating to the appointment of proxy(ies) for the 55th AGM, whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than **Tuesday, 23 June 2026 at 10.30 a.m.**

Corporate members who wish to appoint authorized representative(s) instead of proxy(ies) MUST deposit their ORIGINAL or DULY CERTIFIED certificate of appointment of authorized representative with the Share Registrar of the Company at Muda Management Services Sdn Bhd at Lot 7, Jalan 51A/241, 46100 Petaling Jaya, Selangor Darul Ehsan, Malaysia not later than **Tuesday, 23 June 2026 at 10.30 a.m.**

E. MEETING PROCEEDINGS

- You may enter the meeting hall from **10.00 a.m.** onwards.
- Please ensure that your mobile device(s) is switched off or put on silent mode during the 55th AGM to ensure smooth and uninterrupted proceedings.
- All members or proxies are encouraged to be seated at least 10 minutes before commencement of the 55th AGM.
- Resolutions set out in the Notice of AGM will be considered at the 55th AGM. You will be asked to vote on these resolutions.

F. POLL VOTING AT THE MEETING

The voting at the 55th AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad (“Bursa Malaysia”). The Company has appointed Digerati Technologies Sdn Bhd as the Poll Administrator to conduct the poll by way of electronic voting and Quantegic Services Sdn Bhd as independent scrutineers to verify the poll results.

E-Polling for all the resolutions set out in the Notice of AGM will take place concurrently upon the commencement of the 55th AGM and will remain open throughout the meeting until the conclusion of the deliberation of all businesses to be transacted. All members or proxies can cast their votes electronically by scanning the QR code provided using their personal electronic devices with internet access. They must enter their login credentials to access the E-Poll form and cast their votes, with only the last submitted form being recorded as final. Voting session will close upon the announcement from the Chairman.

Upon completion of the voting session for the 55th AGM, the Independent Scrutineers will verify the poll results, followed by the Chairman’s declaration of the poll results at the 55th AGM. Subsequently, the poll results will be announced via an announcement by the Company through Bursa Malaysia at www.bursamalaysia.com.
